Corrigendum to Regulation (EU) 2024/1252 of the European Parliament and of the Council of 11 April 2024 establishing a framework for ensuring a secure and sustainable supply of critical raw materials and amending Regulations (EU) No 168/2013, (EU) 2018/858, (EU) 2018/1724 and (EU) 2019/1020

1. On page 42, paragraph 4 of Article 30:

for: '4. The Commission shall verify, at least every three years from the date of application of any implementing act adopted pursuant to paragraph 2, that it continues to fulfil the criteria laid down in Annex IV, or a recognised subset of those criteria.'

read: '4. The Commission shall verify, at least every three years from the date of application of any implementing act adopted pursuant to paragraph 2, that the scheme continues to fulfil the criteria laid down in Annex IV, or a recognised subset of those criteria.'
